A motion was made by Councilwoman Miner to approve the minutes for the special-call meeting of March 29, 2018 as written. Motion was second by Councilman Corpening. Carried 4 – 0 – 1 (Mayfield abstain)

New Business: Mayor Miner opened two mowing bids. Leroy Ming bid \$243.00 and J&A Services bid \$975.00.

Mayor Miner appointed William Brandt and Mike Meenan to the Zoning Committee.

Councilman Mayfield made a motion to accept the mayor's appointments of William Brandt and Mike Meenan to the Zoning Committee. Motion was second by Councilwoman Miner. Carried 5 – 0

Councilman Ming made a motion to rent two Port-a-Pottys a \$95.00 each for Saturday in the Park. Motion was second by Councilman Mayfield. Carried 5 – 0

Councilman Mayfield left the meeting at 8:18 p.m.
